Please note you must conduct an inspection, at least annually, during the second quarter, of your facility to recertify that your facility is maintaining compliance with the SPPP. Record the results of these inspections in a report maintained with the SPPP, and submit an Attachment D (annual recertification) to the Department each year. The recertification should be submitted to the Division of Water Quality, Bureau of Non-Point Source Permitting, P.O. Box 029, Trenton, New Jersey 08625, (609) 633-7021, certifying that the inspection was conducted.



Please be advised, as indicated on the Annual Attachment D recertifications, submission of certifications and documents indicating that source materials have been prevented or eliminated, and that the SPPP has been fully implemented when source materials have not been prevented or eliminated may be construed as falsification and be subject to civil administrative penalties.

You are required to institute the corrective measures as specified in the enclosed Notice of Violation.
