The Delaware Riverkeeper Discusses “The Big Uneasy” Film and the Army Corps of Engineers History of Errors

Princeton, NJ: On December 19, 2012, the Princeton Farmers Market will host a screening of the Harry Shearer film “The Big Uneasy,” an exploration of the errors in engineering and judgment by the Army Corps of Engineers that led to the tragic flooding of New Orleans. The program will take place in the Community Room of the Princeton Public Library from 7:00 PM to 9:00 PM. The Delaware Riverkeeper Maya van Rossum will introduce the film and highlight how local citizens are dealing with similar issues in the Delaware River watershed with the proposed deepening of the Delaware River. In a closing discussion, the Delaware Riverkeeper will talk about the erroneous assumptions behind the deepening project, and the parallels between what is documented in the film and what is happening in the Delaware River Watershed.

The film screening comes on the heels of a new report issued by the Delaware Riverkeeper Network and a coalition of taxpayer and community organizations that demonstrates how the Army Corps of Engineers has manipulated their calculations to exaggerate the benefits of the deepening project. “This new report documents once again the boondoggle that is the Delaware River deepening project,” says Maya van

Rossum, the Delaware Riverkeeper. “Deepening is not needed for the ports, it loses money for taxpayers, it harms our River and all the jobs dependent upon a healthy Delaware and its healthy fisheries.”
