## PA Organizations to Launch Citizens Marcellus Shale Commission

HARRISBURG, PA – On Tuesday, August 30, there will be the announcement of a new commission that will give the citizens of Pennsylvania an opportunity to tell their side of the story about drilling in the Marcellus Shale. Reporters and editors are invited to participate in a media conference call at 11 a.m.

The Citizens Marcellus Shale Commission, co-chaired by former state Representatives Carole Rubley and Dan Surra, will hold hearings across Pennsylvania to gather citizen perspectives on the Marcellus Shale and produce a final report for policymakers.

Delaware Riverkeeper Maya van Rossum has been appointed one of the panel's Commissioners. "This is an important opportunity for citizens, experts, and those with relevant experiences and knowledge to share their information about gas drilling so a truly informed set of considerations can be shared with Pennsylvania elected officials and agency representatives," said van Rossum.
